A mistake in adding up a customer's purchase or calculating a 20% off coupon could lead to lost revenue, customer dissatisfaction, or even inventory discrepancies. The 2020 version often included additional questions related to counting back change (the method of giving change by counting up from the purchase amount) and handling multiple discounts, reflecting Hobby Lobby’s frequent coupon promotions.

Sample Question Types from the Hobby Lobby Math Test 2020

To give you a concrete idea, here are examples of the kind of questions you might encounter:

1. **Addition:** “A customer buys items priced at \$12.49, \$6.99, and \$3.50. What is the total?” (Answer: \$22.98)

HOW THE HOBBY LOBBY MATH TEST CHANGED IN 2020

While the mathematical content remained largely the same, the delivery and context of the **Hobby Lobby Math Test 2020** experienced several notable shifts. The most significant change was the transition from in-person, paper-based exams to online, proctored assessments. This allowed applicants to take the test from the safety of their homes, but it also introduced new challenges. For example, test-takers had to ensure they had a stable internet connection and a quiet environment. Additionally, some applicants reported that the online interface made it harder to show their work or double-check calculations, as they could not easily write on the screen. Practice Mental Math Daily

Set aside 10–15 minutes each day to solve basic arithmetic problems without a calculator. Review Basic Decimal and Fraction Operations

Remember that retail prices often end in .99 or .49. Learn to round up mentally to the nearest dollar and then subtract. For example, \$12.99 is nearly \$13.00. This trick can help you add multiple items faster. Also, understand that 50% is half, 25% is a quarter, and 10% is one-tenth. Knowing these benchmarks makes percentage-off calculations easier.
