typically refers to the official guideline that a high-quality page has a clear beneficial purpose, demonstrates high E-A-T, and is well-maintained.

## Scenario-Based Rating Decisions

## Identifying Spam or Low-Quality Pages

harmful) and "low quality" (useless but not necessarily malicious) is key.

# User Intent Matching

For a given query, you must determine the primary user intent. Example: query "best noise cancelling headphones 2025" — the intent is commercial investigation (transactional/informational mix). Part 1 may ask you to match queries to intent categories.
