# Step 1: Obtain Raw Scores for Each Subtest

# Step 2: Convert Raw Scores to Scaled Scores Using the Appropriate Table

During administration, the examiner records the examinee's responses and computes raw scores according to the manual's rules. For example, on the Block Design subtest, raw score points are awarded for correctly completed designs within time limits. On Vocabulary, each item receives 0, 1, or 2 points. Once raw scores are tallied, the examiner turns to the scoring tables.

The WAIS-IV manual provides separate raw-to-scaled score tables for each age group (e.g., 16:0-17:11, 18:0-19:11, and so on). The examiner locates the table corresponding to the examinee's age.

For instance, a 22-year-old would use the table for ages 20:0–24:11. Within that table, each subtest has its own column. By finding the raw score in that column, the examiner reads across to the scaled score (typically ranging from 1 to 19).

For example, a raw score of 32 on Vocabulary for a person aged 22 might convert to a scaled score of 13, while the same raw score for a 70-year-old might convert to a scaled score of 16 because older adults generally have lower raw scores on that subtest. This age adjustment is a critical feature of the WAIS-IV scoring tables.

## Step 3: Sum Scaled Scores to Derive Composite Scores

After obtaining scaled scores for all required subtests, the examiner sums the scaled scores for each index. The four primary indexes are:

- **Verbal Comprehension Index (VCI)** – typically includes Similarities, Vocabulary, and

Information.

- **Perceptual Reasoning Index (PRI)** – typically includes Block Design, Matrix Reasoning, and Visual Puzzles.
- **Working Memory Index (WMI)** – typically includes Digit Span and Arithmetic.
- **Processing Speed Index (PSI)** – typically includes Symbol Search and Coding.

Full Scale IQ (FSIQ) is computed from the sum of scaled scores across all ten core subtests. The scoring tables also provide conversion from these summed scaled scores to composite scores (index scores and FSIQ). Again, age-specific tables are used. For example, a sum of scaled scores of 60 on the VCI for a 30-year-old

might correspond to a VCI composite score of 115, which falls in the High Average range.

## Step 4: Interpret Scores Using Normative Ranges

Once composite scores are obtained, they are categorized using the standard classification system:

- 130 and above: Very Superior
- 120–129: Superior
- 110–119: High Average

- 90–109: Average
- 80–89: Low Average
- 70–79: Borderline
- 69 and below: Extremely Low

These classifications are derived from the normative data embedded in the scoring tables.

# Age-Based Norming

One of the most important features is the use of **age-based norms**. Cognitive abilities change across the lifespan. For example, processing speed tends to

decline with age, while verbal knowledge remains stable. The WAIS-IV scoring tables account for these changes by providing separate conversions for each age band (e.g., 16–17, 18–19, 20–24, 25–29, etc., up to 85–90). # Scaled Score Distribution

Scaled scores on each subtest follow a normal distribution with a mean of 10 and a standard deviation of 3. Approximately 68% of the normative sample scores between 7 and 13. Scores from 1 to 19 cover the full range of

abilities. The scoring tables are meticulously constructed so that the raw-score-to-scaled-score conversion yields this distribution for every age group.

## Composite Score Distribution

Index scores and Full Scale IQ use a mean of 100 and standard deviation of 15. This is a familiar metric for most professionals. The conversion tables for composites are also age-adjusted. A composite score of 100 always represents the average performance for that age group.

## Subtest Specificity

using a ruler or guide can help prevent mistakes.

## Neglecting to Sum Scaled Scores Correctly
