SOURCING PRODUCTS FOR YOUR EBAY BUSINESS

CREATING EFFECTIVE EBAY LISTINGS

Your product listing is your storefront, and creating high-quality listings is a critical skill when learning how to start an eBay business. A well-crafted listing can dramatically improve your visibility in search results and convince buyers to make a purchase. Focus on three key elements: titles, descriptions, and photographs.

eBay's search algorithm relies heavily on titles. Include your primary keywords early in the title, followed by important attributes like brand, model, size, color, and condition. Avoid filler words like "lot," "amazing," or "rare" unless they are genuinely accurate. A good title structure might look like this: "Vintage Rolex Submariner 16610 Men's Watch - Stainless Steel - Used." This title includes the brand, model, key features, and condition, all of which

help buyers find your listing.

Crafting Detailed Product Descriptions

Your description should provide all the information a buyer needs to make a confident purchase. Include dimensions, materials, any defects or signs of wear, and the reason for selling. Be honest and transparent. Use bullet points to make the description easy to scan, and highlight the most important features at the top. Good descriptions reduce the likelihood of

returns and disputes, which is essential when you are building a reputation as a new seller.

Taking Professional Photographs

High-quality photographs are non-negotiable on eBay. Use natural lighting or a lightbox to ensure your products are well-lit and accurately represented. Take multiple photos from different angles, including close-ups of any flaws. The first photo should be a clean, front-facing shot on a neutral

background. eBay allows up to 24 free photos per listing, so take advantage of this to showcase your item thoroughly. Listings with clear, detailed photos consistently sell for higher prices and receive fewer returns.

PRICING AND SHIPPING STRATEGIES

Using Promotions And Markdowns
