The Court stated: "*The commissioner here could not know from the affidavit anything about the informant's credibility, nor could he know the basis of the informant's knowledge. The affidavit, therefore, was insufficient to support a finding of probable cause.*"

The Two-Pronged Test Explained in Detail

The Aguilar test provides a structured framework for evaluating the sufficiency of informant-based probable cause. Each prong serves a distinct purpose in ensuring that magistrates have a meaningful basis for issuing warrants.

The Basis of Knowledge Prong: This prong requires that the affidavit contain specific facts that show how the informant came to know the information. For example, did the informant personally observe the illegal activity? Did the informant overhear conversations? Or did the informant simply hear about it from a third party? The purpose is to allow the magistrate to

assess the likelihood that the information is accurate based on the informant's direct or indirect access to the facts.
