- **Runoff:** The movement of pesticides over the soil surface into waterways, often caused by heavy rain or over-irrigation.
- **Volatilization:** The transformation of a pesticide from a liquid or solid into a gas, which can travel long distances.
- **Drift:** The airborne movement of pesticide particles or droplets away from the target

site during application.

You will need to know how weather conditions—especially wind speed and temperature inversions—affect these processes. Oklahoma’s often windy climate makes drift management a critical topic.

# Pesticide Safety and Emergency Response

Safety is paramount. The exam will ask about the correct use

of PPE, how to handle a pesticide spill, and how to respond to poisoning. Common questions involve:

- The route of entry (dermal, inhalation, oral, ocular)

Several online resources offer practice exams that mimic the format and difficulty of the real test. These tools are far better than static answer lists because they help you identify your weak areas. When you get a practice question wrong, go back to the manual and review that specific section. This active learning process is much more effective than passive memorization.

# Focus on Calculations

Many test takers struggle with the math section. You will need to calculate correct mixing rates, tank volumes, and application rates. Common calculations include:

- Calibration of sprayers and spreaders
- Determining how much pesticide to add to a partially filled tank
- Converting between ounces, pints, quarts, and gallons per acre

Practice these calculations

repeatedly.

Understanding the "why" behind the math will help you solve problems even if the exact numbers change.

## Join a Study Group or Take a Training Course

Oklahoma State University Extension offers training courses and workshops for pesticide applicators. These classes are taught by experienced agronomists and provide an opportunity to ask questions. Many county extension offices also host study

sessions. Engaging with peers and instructors can clarify confusing concepts and provide real-world context.

### **SAMPLE EXAM QUESTIONS AND CONCEPTS**

IPM-appropriate answer.

### HOW TO HANDLE "TRICK" QUESTIONS

---

Some exam questions are designed to test your attention to detail. For example, a question may ask for the "least" toxic pesticide or the "slowest" method of pesticide degradation. Always read the entire question carefully and look for qualifying words like "most," "least," "first," "best," or "most effective." If you have only memorized a list of answers without understanding context, these subtle differences will trip you up.

### MAINTAINING YOUR

## **CERTIFICATION**

---

Passing the initial exam is only the first step. In Oklahoma, pesticide applicator certifications must be renewed periodically. Private applicators typically need to renew every three years, while commercial applicators may need to recertify annually. To recertify, you must either attend approved continuing education (CEU) courses or retake the exam. Staying current with new regulations, changing label requirements, and emerging pest threats is part of your professional responsibility.
