WHAT IS A CONTRACT? A FOUNDATIONAL DEFINITION

THE ESSENTIAL ELEMENTS OF A VALID CONTRACT

Offer and Acceptance: The Building Blocks of Agreement

An offer must be distinguished from an invitation to treat, which is merely an invitation to enter into negotiations. Acceptance is the unqualified agreement to all the terms of the offer. It must be communicated to the offeror, either expressly or by conduct. Silence generally does not constitute acceptance. The acceptance must mirror the terms of the offer exactly; any variation constitutes a counter-offer, which effectively rejects the original offer. The postal rule provides a notable exception regarding the timing of acceptance, where acceptance by post takes effect when the letter is posted, not when it is received.

Consideration: The Price of a Promise

Consideration is a fundamental concept in contract law, particularly in common law jurisdictions. It refers to something of value exchanged between the parties. Each party must give, or promise to give, something of benefit to the other, or suffer some detriment. Consideration distinguishes a binding contract from a gratuitous promise, which is generally unenforceable. For instance, if A promises to give B a gift, there is no consideration from B, and no contract exists. However, if B promises to pay A in

return, consideration is present.

Consideration need not be adequate, but it must be sufficient. Courts do not generally inquire into whether the value exchanged is fair or equal—this is a matter for the parties to decide. However, consideration must be real and have some economic value. It cannot be illusory or past. Past consideration, meaning something already done before the promise was made, is not valid consideration for a new promise.

Intention to Create Legal Relations

Not every agreement, even with offer, acceptance, and consideration, constitutes a contract. The parties must also intend their agreement to be legally binding. This requirement prevents trivial social or domestic arrangements from becoming enforceable contracts. Courts use objective tests to determine intention, examining what a reasonable person would infer from the parties conduct and circumstances.

In commercial contexts, there is a strong presumption that parties intend to create legal relations. Agreements between business people are generally assumed to be binding unless expressly stated otherwise. In social or domestic contexts, the opposite presumption applies. Agreements between family members or friends are presumed not to create legal relations, unless clear evidence suggests otherwise. These presumptions can be rebutted by the particular facts of each case.

Capacity to Contract

For a contract to be valid, all parties must have the legal capacity to enter into it. Certain categories of persons are deemed by law to lack full contractual capacity, including minors, persons with mental incapacity, and intoxicated persons. The rules surrounding capacity aim to protect vulnerable individuals while balancing the legitimate interests of those who deal with them.

Minors, generally persons under eighteen, have limited capacity to contract. Contracts for necessities, such as food, clothing, and education, are binding on minors. Contracts for employment or apprenticeship that are for the minors benefit may also be binding. However, other contracts entered into by minors are voidable, meaning the minor can choose to enforce or repudiate them upon reaching majority. Persons with mental incapacity may avoid contracts if they can prove they could not understand the nature of the transaction and the other party knew or ought to have known of their incapacity.

Legality of Purpose

A contract must have a lawful purpose to be enforceable. Agreements that involve illegal activities, contrary to public policy, or that seek to oust the jurisdiction of the courts are void and unenforceable. This requirement ensures that the courts are not used to enforce immoral or socially harmful arrangements. Examples include contracts for illegal gambling, contracts to commit a crime, or contracts that restrain trade unreasonably.

The doctrine of illegality operates both to protect the integrity of the legal system and to deter unlawful conduct. Courts will not assist a party to recover benefits under an illegal contract, even if that party was unaware of the illegality in some cases. However, the rules are complex, and exceptions exist where the illegality is not central to the contract or where public policy favours granting relief.

TYPES OF CONTRACTS: CLASSIFICATION AND DISTINCTIONS

Express and Implied Contracts

An express contract is one where the terms are explicitly stated, either orally or in writing. The parties have clearly articulated their agreement. For example, in a contract for the sale of goods, the seller promises to deliver the goods, and the buyer promises to pay the price. A unilateral contract, on the other hand, involves a promise by one party in exchange for an act by the other party. The offeror promises to pay if the offeree performs a specified act. The offeree does not promise to perform but can accept only by completing the act. Classic examples include reward offers for finding a lost pet or completing a task.

Formal and Simple Contracts

Formal contracts, also known as contracts under seal or deeds, derive their validity from their form rather than the presence of consideration. They must be in writing, signed, witnessed, and delivered. Simple contracts, which constitute the vast majority of contracts, require consideration but need not be in any particular form, though writing may be required for certain types of contracts under statutes of frauds.

TERMS OF A CONTRACT: EXPRESS, IMPLIED, AND INCORPORATED

The terms of a contract define the rights and obligations of the parties. They can be express, meaning explicitly agreed upon, or implied, meaning read into the contract by law or custom. Understanding the difference between terms and mere representations is crucial. Representations are statements made during negotiations that induce the contract but do not become binding terms. If a representation proves false, it may give rise to an action for misrepresentation rather than breach of contract.

Express terms are those actually stated by the parties, whether orally or in writing. Implied terms fill gaps in the agreement based on the presumed intention of the parties, legal requirements, trade custom, or the need to give business efficacy to the contract. Conditions, Warranties, and Innominate Terms

to terminate the contract and claim damages. A warranty is a less important term. Breach of a warranty entitles the innocent party to claim damages but not to terminate the contract. Courts have also recognised innominate terms, where the remedy depends on the severity of the breach and its consequences rather than a predetermined classification.

BREACH OF CONTRACT AND AVAILABLE REMEDIES

When a party fails to perform their obligations under a contract, a breach occurs. The remedies available depend on the nature and seriousness of the breach. The primary goal of contract remedies is to place the innocent party in the position they would have been in had the contract been performed, not to punish the breaching party.

Damages are the most common remedy. They aim to compensate the innocent party for actual loss suffered as a result of the breach. Damages are measured either by the expectation interest, giving the plaintiff the benefit of the bargain, or by the reliance interest, reimbursing expenses incurred in reliance on the contract. The concept of remoteness of damage limits recovery to losses that were foreseeable at the time of contracting or within the reasonable contemplation of the parties.

Specific performance is an equitable remedy requiring the breaching party to perform their contractual obligations. It is available only where damages are inadequate, such as in contracts for the sale of unique property. Specific performance is discretionary and will not be granted where it would cause undue hardship or require constant supervision. Injunctions may also be

available to restrain a party from breaching a contract, such as enforcing a negative covenant.
