2021 Debt Collection Rule, which clarified aspects of the Fair Debt Collection Practices Act—set the standard for industry best practices. You must implement procedures for electronic communication, voicemail restrictions, and record-keeping that align with these rules. Some agencies also charge upfront fees for skip tracing (locating debtors) or legal processing, but this is less common in consumer debt collection due to regulatory concerns. Your projections should account for operating expenses, employee salaries, software subscriptions, and licensing fees, all while estimating your collection rate and average fee percentage.
