- **Making Certified Copies** – Providing certified copies of authentic acts that are in the notary’s permanent records.
 - **Performing Marriage Ceremonies** – A notary may solemnize marriages, but only if the notary also possesses a specific authorization (e.g., being a justice of the peace or having a special commission).

Limitations and Prohibitions

While powerful, a Louisiana notary is not an attorney. The notary cannot give legal advice, represent clients in court, or prepare pleadings (with very narrow exceptions). The line between drafting a legal document (which a notary may do under the “blank form” doctrine) and practicing law (which requires a law license) is a constant source of debate and is an essential topic in **Louisiana Notarial Law And Practice**.
