- **Discuss with peers and instructors:** Solutions should complement, not replace, discussions in tutorial group sessions. Bring your solution-related questions to the group and see if you can explain the reasoning to someone else.

3. **Over-reliance on solution manuals:** Some students purchase instructor solution guides. While these are usually accurate, using them as a shortcut can lead to a false sense of understanding. The exam will not have the same problems; you need to grasp the underlying concepts.
4. **Copying without thinking:** The most common pitfall is copying solutions verbatim for homework credit. This not only violates academic integrity policies but also ensures that you will struggle on exams. The tutorials are designed to teach you how to think like a physicist—that skill cannot be copied.

### CASE STUDY: A SAMPLE PROBLEM FROM THE ELECTROSTATICS TUTORIAL

To illustrate the depth required in a good solution, consider a typical problem from the electrostatics section: *Two identical conducting spheres, one with charge  $+3Q$  and the other with charge  $-Q$ , are brought into contact and then separated. Determine the final charge on each sphere.*
