## 4. Journal Keeping and Record Retention

While Utah does not mandate a notary journal (unlike many states), it is strongly recommended. Also know that journals are public records and must be kept for at least ten years after the last entry.

## 5. Electronic Notarization (RON) – 2021 Updates

In response to the pandemic, Utah expanded remote online notarization (RON) laws. Once you pass the exam (score of 80% or higher), you must complete the following within 60 days:

1. File your commission application with the Lieutenant Governor’s office (fee \$20).
2. Purchase a \$10,000 notary surety bond from an authorized company.
3. Take the oath of office at your county clerk’s office (bring your bond and commission certificate).
4. Receive your commission and obtain a notary seal/stamp.
5. Optionally purchase a journal and errors & omissions insurance.

Your four-year commission begins once you take the oath. Renewal requires passing the exam again only if your commission lapses for more than 90 days.
