Each class requires passing a specific general knowledge test. Additionally, if you plan to operate certain specialized vehicles, you will need to pass endorsement tests.

## Requirements for Passing

To pass any Oregon CDL knowledge test, you must achieve a score of at least 80 percent. Some endorsement tests also require an 80 percent score. If you fail a test, you can retake it, but there may be a waiting period and additional fees. The Oregon DMV allows you to retake the test the same day in some cases, but this depends on the specific office policy. However, retaking the test without additional study is rarely successful. Taking multiple practice tests beforehand significantly reduces the chance of failure.
