RETHINKING RIGOR: RELIABILITY AND VALIDITY IN QUALITATIVE RESEARCH

For decades, the words "reliability" and "validity" were firmly rooted in the language of quantitative research. If you could not measure something with a precise instrument and replicate the result, many traditional

scientists considered the findings questionable. However, as qualitative research gained prominence across fields such as sociology, education, nursing, and market research, a critical question emerged: How do we judge the quality of research that explores human experience, meaning, and context rather than numbers and statistical probabilities? The answer is not as simple as applying quantitative standards to qualitative data. Instead, scholars have

developed robust frameworks to ensure **reliability and validity in qualitative research** remain meaningful and rigorous. When researchers talk about reliability and validity in qualitative research, they are generally referring to the **trustworthiness, credibility, dependability, and confirmability** of the study. expectations when you are working with a thermometer, a standardized test, or a laboratory scale. But qualitative research deals with human beings, their perceptions, their evolving narratives, and the unique contexts in which they live.

Consider a researcher conducting in-depth interviews about grief. If they interview the same person twice, the responses might differ not because the method is flawed, but because grief changes, memories shift, and people reflect differently over time. Expecting identical answers would actually indicate a lack of sensitivity to the human experience. Similarly, if two researchers observe

the same classroom, they may notice different interactions. That does not mean one is wrong. It could mean they each captured authentic but different slices of reality.

Because of these nuances, scholars like **Lincoln and Guba** proposed an alternative paradigm for evaluating qualitative research. They introduced the concept of **trustworthiness**, which includes four key components:

credibility, **transferability**, **dependability**, and **confirmability**. These four pillars serve as the qualitative equivalents of internal validity, external validity, reliability, and objectivity.

Understanding this

framework is the foundation for any meaningful discussion about reliability and validity in qualitative research.

Credibility y as the Qualitativ e Counterp art to Internal Validity

Credibility asks whether the findings are a true and accurate representation of the participants' experiences. In simple terms, did the

researcher actually capture what the participants meant? There are several established techniques to strengthen credibility in a qualitative study:

- **Prolonged engagement:**
Spending sufficient time in the field or with participants helps the researcher understand the culture, build trust, and reduce the effects of their own presence.
- **Persistent observation:**
Going beyond surface-level impressions to identify the most relevant characteristics and nuances in the setting.

- **Triangulation:**

Using multiple data sources, methods, investigators, or theories to cross-check findings. For example, combining interviews with observations and document analysis provides a richer, more credible picture.

- **Member checking:**

Returning the findings or interpretations to the participants and asking them whether the researcher's understanding matches their own experience. This is one of the most powerful tools for ensuring accuracy.

- debriefing:**

Discussing the study process and findings with colleagues who are not directly involved in the research, allowing them to challenge assumptions and identify blind spots.

When readers see that a researcher has employed these strategies, they can have greater confidence in the credibility of the work. Without credibility, the entire study collapses, regardless of how elegantly it is written.

External validity in quantitative research asks whether results can be generalized to other populations or settings. Qualitative researchers recognize that their work is often deeply contextual. However, that does not mean findings are useless outside the original study. The concept of **transferability** shifts

the burden of judgment from the researcher to the reader.

To enable transferability, the researcher must provide what is called **thick description**.

This means offering rich, detailed accounts of the context, the participants, the setting, and the processes involved. If you describe the culture of an urban high school with enough depth and specificity, an educator in a similar school can decide whether the findings might apply to their own situation.

Think of it as providing a detailed map. The researcher does not claim that every school is the same, but by drawing the map carefully, they allow others to see which

features match and which do not. Transferability is not about statistical generalization; it is about offering enough detail for informed, contextual comparisons.

Dependability as the Qualitative Counterpart to Reliability

If reliability is about consistency over time, **dependability** accounts for the fact

that qualitative research settings are inherently unstable. The goal is not to freeze a moment in time, but to ensure that the research process is logical, documented, and transparent. Another researcher should be able to follow the decision trail and understand how the researcher arrived at their conclusions.

Strategies for enhancing dependability include:

- **Audit trails:** Keeping comprehensive records of raw data, field notes, analysis notes, and methodological decisions. A well-maintained audit trail allows external

reviewers to assess whether the conclusions are supported by the data.

- **Reflexive journaling:**

Writing regularly about the researcher's own thoughts, biases, and reactions during the study. This helps separate the participant's voice from the researcher's interpretation.

- **External audits:** Inviting an independent researcher to examine the process and findings to check for consistency and coherence.

Confirmability as the Qualitative Counterpart to Objectivity

Dependability acknowledges that change is expected. If a participant changes

Objectivity is a contentious word in qualitative circles because most qualitative researchers reject the idea that any human observer can be entirely neutral. However, **confirmability** offers a practical alternative. Rather than requiring the researcher to be a blank slate, confirmability asks whether the findings are genuinely grounded in the data, rather than being products of the researcher's biases, motivations, or interests.

This is where the audit trail becomes especially valuable. If a researcher claims that participants expressed frustration with a

policy, the audit trail should show the specific interview excerpts, field notes, and analytic memos that led to that interpretation.

Confirmability is not about eliminating the researcher's perspective, but about making the interpretive process visible and open to scrutiny.

Techniques such as **reflexivity** (examining how your own background affects the research) and **negative case analysis** (actively looking for data that contradict emerging themes) further strengthen confirmability. When a researcher can point to evidence that challenges their own preferred narrative, it signals intellectual honesty and

strengthens the overall trustworthiness of the study.

PRACTICAL STRATEGIES FOR ENSURING RELIABILITY AND VALIDITY IN QUALITATIVE RESEARCH

It is one thing to understand the theoretical framework; it is another to apply it in the field. Below are actionable steps that researchers can take to embed rigor into every phase of a qualitative study.

During the Design

Phase

Start with a clear **research question** that is well-suited to qualitative inquiry. A vague question produces vague findings. Choose a methodology that aligns with your question. Ethnography, grounded theory, phenomenology, and case study each come with their own standards for quality and rigor.

Develop an **interview or observation protocol** and pilot test it. A pilot test can reveal whether your questions are confusing, leading, or overly broad. It gives you a chance to refine your approach before committing to the full study.

During Data Collection

Collect data until you reach **thematic saturation**. Saturation means that new data no longer generate new insights or themes relevant to your research question. This is a critical marker of completeness. However, be careful not to confuse saturation with repetition. True saturation requires that you have thoroughly explored the dimensions of each theme.

Record and transcribe interviews verbatim. If possible, use professional transcription services

or take the time to check transcripts against the original recordings. Even a small error in transcription can alter the meaning of a statement.

Maintain detailed **field notes** that capture not only what was said, but also the setting, non-verbal cues, and your own immediate reflections. These notes become invaluable during analysis and when establishing dependability and confirmability.

During Data Analysis

Use systematic coding processes. Whether you use manual coding

or qualitative data analysis software, document your coding framework and explain how codes evolve into categories and themes. A clear analytic process is central to both dependability and confirmability.

Engage **investigator triangulation** if you have a research team. Having multiple people code the same data and then compare their interpretations can highlight biases and enrich the analysis. If you are working alone, consider asking a colleague to code a subset of your data independently.

Search for **disconfirming evidence**. Actively look for cases, quotes, or observations that challenge your emerging themes.

Addressing these counterexamples directly in your write-up strengthens credibility and shows that you have considered alternative interpretations.

During Writing and Reporting

Be transparent about your methods. Explain exactly how you collected data, how many participants you interviewed, how you analyzed the material, and what steps you took to ensure trustworthiness. A methods section that glosses over these details will raise immediate red flags for

COMMON readers.

Use direct quotes generously but thoughtfully. Quotes allow the participants to speak for themselves and provide evidence for your claims. However, avoid overusing quotes as a substitute for analysis. Your job is to interpret and contextualize the participants' words, not just report them.

Reflect on **your own positionality**. Include a statement about how your background, assumptions, and relationship with participants may have shaped the research. This is not an exercise in self-indulgence; it is a mark of methodological maturity that enhances confirmability.

MISCONCEPTIONS ABOUT RELIABILITY AND VALIDITY IN QUALITATIVE RESEARCH

Despite growing acceptance of qualitative methods, misconceptions persist. One common error is the belief that qualitative research is inherently less rigorous than quantitative research. This is only true if you apply the wrong standards. A qualitative study that uses member checking, thick description, triangulation, and a clear audit trail is no less rigorous than a randomized controlled trial. It is simply rigorous in different ways.

Another misconception

is that reliability is irrelevant in qualitative research. While the term may be reframed as dependability, the underlying value is still critical. Readers need to trust that the research process was conducted in a careful, transparent, and coherent manner. Without that trust, the findings carry little weight.

Some researchers also mistakenly believe that subjectivity is the enemy of qualitative research. In reality, subjectivity is the raw material of qualitative inquiry. The goal is not to eliminate it, but to manage it through systematic reflection and transparent reporting. A researcher who pretends to be entirely objective is

likely hiding more than they reveal.

CONCLUSION

Reliability and validity in qualitative research may look different from their quantitative counterparts, but they are no less important. By reframing these concepts as **trustworthiness**—encompassing credibility, transferability, dependability, and confirmability—qualitative researchers have developed a robust and appropriate framework for evaluating the quality of their work.
