## Checking for Errors

A large part of a stock worker's job involves verifying orders and spotting discrepancies. The exam may include questions where you compare lists of part numbers, quantities, or codes to find differences.

You will be presented with step-by-step instructions (e.g., how to process a return or how to store hazardous materials) and asked to select the correct sequence or identify the missing step. This ensures you can follow MTA standard operating procedures.

## 5. Following Direction and Equipment Knowledge

Basic knowledge of safe lifting techniques,



proper use of personal protective equipment (PPE), and familiarity with warehouse equipment like pallet jacks and forklifts may be covered. Some questions may also test your understanding of Material Safety Data Sheets (MSDS).
