Step 2: Gather High- Quality Study Materials

When selecting materials, look for resources that include detailed explanations of tax concepts, practice questions with answer rationales, and simulated exams that mirror the format of the actual test. For employment taxes, focus on the distinctions between employees and independent contractors, as well as the reporting requirements for Forms 941, 940, and W-2.

Strategies for Part 3: Represen

tation, Practices, and Procedures

Part 3 is unique because it tests your understanding of how to interact with the IRS on behalf of clients. Start by thoroughly reading Circular 230, which is the foundation of ethical practice for EAs. Focus on the rules regarding client confidentiality, conflicts of interest, fees, and advertising. Also, study the procedural aspects of IRS audits, appeals, and collections. Understand the hierarchy of IRS

authority, including the role of the Taxpayer Advocate Service, and know the differences between various types of IRS notices and correspondence.

Practice scenarios where you must determine the appropriate response to a client request or an IRS inquiry. Role-playing these situations with a study partner can be very effective for this section.

Tax law is detail-heavy, and cramming leads to confusion. Spaced repetition, where you review material at increasing intervals over time, is far more effective. Plan your schedule to allow for regular review of previous topics as you move forward.

Ignoring Updates in Tax

Tax laws change frequently, and the SEE is updated to reflect current law. Make sure your study materials are for the current exam year. Using outdated guides can cause you to learn incorrect information and miss important changes.

TEST-DAY TIPS FOR ENROLLED AGENT CANDIDATES

When exam day arrives, being prepared mentally and logistically is just as important as knowing the material. Here are some practical tips to ensure you perform your best.

First, confirm your appointment details, including the location

and time. Arrive early to allow for check-in procedures. Bring valid identification and any materials you are permitted to use. Note that the SEE is a closed-book exam, so you will not be allowed to bring notes or reference materials.
