## The Divergence ( $\nabla \cdot F$ ): The Source of the Flow

If the gradient is about the *slope* of a scalar quantity, divergence is about the *balance sheet* of a vector quantity. The divergence operator acts on a vector field ( $F$ ) and produces a scalar field. It measures the net rate of "outflow" of a vector field from an infinitesimally small volume around a point.
