## Reflexive Verbs and Daily Routine

Chapters on daily routine require students to master reflexive pronouns (*me, te, se, nos, os, se*). Students often confuse *Me lavo las manos* (I wash my hands – reflexive action on oneself) with *Yo lavo el coche* (I wash the car – direct object). Using the answer key for workbook exercises focused on reflexive verbs allows you to immediately see if you have correctly matched the pronoun to the subject and determined if the verb is being used reflexively.

## Direct and Indirect Object Pronouns
