Understand Drug Classifications Rather Than Individual Drugs

Focus High- Yield Medications and Frequently Tested Topics

STRATEGIES FOR PHARMACOLOGY

Use Active Recall and Spaced Repetition

When answering SATA questions, treat each option as a true-or-false statement and select only those that are clearly correct. Avoid overthinking incomplete or vague options.

and Prioritization

Some pharmacology questions require you to place steps in the correct order, such as the sequence for administering insulin or the proper order for checking intravenous lines. Prioritization questions ask you to identify which patient to see first or which intervention to perform immediately. For example, a question might present four patients with different medication-related issues and ask which one requires the most urgent attention. Your ability to recognize life-threatening adverse effects and prioritize accordingly is

essential.

Dosage Calculation Questions

Dosage calculations are a staple of NCLEX-RN pharmacology. These questions test your ability to calculate correct dosages based on patient weight, body surface area, or prescribed concentration.
