## 5. Closing and Signatures

The document often ends with a benediction and is signed by the pastor, a committee chair (if a committee drafted it), and sometimes the church clerk. The date of adoption is also included.

### THE PROCESS OF DRAFTING AND ADOPTING A FUNERAL RESOLUTION

In many Baptist churches, the responsibility for preparing a funeral resolution falls to a special committee, often composed of the pastor, deacons, or members of the bereavement ministry. Here is a typical process:
